**विषय: Domiciliary Payment for late submitter of Life Certificate, 2021**

महोदय/ महोदया,

This is in reference to the domiciliary payment of CPRMSE beneficiaries. As per the policy in vogue, the retired executives need to submit their Life Certificate every year in the month of NOVEMBER.

**"Clause No: 5.4. All the retired Executives and/ or spouses will have to submit either a "Life Certificate" or a "Jeevan Pramaan Certificate/ Digital Life Certificate" every year in the month of November."**

However, the members continue to submit/ send Life Certificate even on the date and insist on the payment to be made.

In view of the above, considering this to be the first year when the Life Certificate amendment was introduced; the Competent Authority has accorded his approval to the effect **that Life Certificate received till 31<sup>st</sup> March 2022 shall be considered for the domiciliary payment for 2021.** The Life Certificate received after 31.03.2022 for the year 2021 shall be kept on record but payment shall be processed strictly in terms of O.M No. CIL/C5A(PC)/CPRMSE/614 dated 31.03.2021 i.e. in January 2023 when the payment may be affected along with the previous year's balance.
