

### **MoM of EC meeting held on 28.10.2022 (through Google Meet)**

At the outset one minute silence was observed to pay homage to all the Pensioners of Coal Industry who left heavenly abode including Shri A. K. Lal and Shri Chandrma Mishra.

President briefed about the progress of court case pending in Delhi High court. He informed that the case has reached the stage of 'Part heard', meaning it will be heard by the same bench till its conclusion. He further informed that the brief note will be submitted by our advocates soon as desired by the court. Next hearing is on 21.11.2022.

1. CPRMSE: president informed that it has come to his notice about an issue of SECL, wherein a senior retired executive was refused reimbursement of medical expenses under CPRMSE, citing exhaustion of the total funds (Rs.25 lakhs), though treatment was extended to his spouse under 'specified diseases'. It was opined that this is against the spirit of the scheme and a representation should be addressed to the concerned official from the Federation. Shri.Dattatreya informed that in SCCL accounts are maintained separately for 'specified' and other general diseases.

2. Seminar to be organized:

Shri.Katiyar explained about the details of proposed seminar to be held with the support of Trade Unions, IMMA, SCCL, CMOAI organized by Federation on the subject of "Safety in Mining Industry" in Nagpur in January 2023. Shri Katiyar is the Organizing in charge who has already convened a meeting on this subject in the office of CMOAI.

The surplus generated would be available to the Federation to meet the legal expenses.

3. Pensioners Day:

Shri.S.L.Yadav proposed to hold 'Pensioners Day' on 17.12.2022 at all Coal India Subsidiaries headquarters and at SCCL headquarters.

4. Concern was expressed by the president on the undue delay taking place in completing the auditing of accounts of Federation, filing IT Returns etc. Shri.Katiyar emphasized that getting the funds into Federation account from the proceeds of seminar is dependent on having a PAN number linked to Federation's bank account in Nagpur. Treasurer was asked to expedite the process.

5. Advocate Fee:

President explained in detail the fee being paid to the Sr. Advocate and Srivastava Associates.

6. President read out the message of Shri Bhasin, the G.S. of CIROWA, Nagpur about the Fund collection drive undertaken by him. He has informed that he has collected Rs. 2, 70, 000.00 in the last 2 months' time. Donations by Mrs. Priti, Mr. Gandhi and 4 widows are worth appreciation. The E. B. of Federation expresses gratitude to these personalities and Shri Bhasin for motivating the people.

7. The Executive Body decided to continue the collection drive as the Court Cases are normally a costly affair. And all the Federates are requested to continue their efforts.
