Shri.S.Q.Zama, Shri Shiv Kumar, and Shri S. A. Beg and other Trade union leaders appreciated the efforts of Federation and expressed faith in to resolution of the pension issue under Coal Mines Pension Scheme (CMPS 1998) and expressed their support for the cause.

Shri Satish Gawale the President of WCL, CMOAI too expressed faith and desired support the Federation.

Members expressed the need for proper implementation of CPRMSE and CPRMSNE by continuous follow up by Federation so that the retired employees of coal industry get hassles-free cashless medical treatment in empaneled hospitals.

Executive body meeting of Federation was held at Lambent IT Park, Harihar Nagar, Besa, Nagpur on 12.02.2023 at 5PM after the AGM.

The following points were discussed.

1. It was decided to help the most needy retired employees of Coal Industry who are the Members of Federation through a benevolent fund. A pilot will be launched in Nagpur area. Modalities to be worked out by Shri.S.N. Katiyar.
2. Federation would employ a person on part time basis who may be considered for a full-time engagement in Nagpur after reviewing his use in the next 6 months' time, to be a single point contact for communicating with office bearers, the members of federation and maintaining records of Federation. Sri.Katiyar would provide the office space in his office premises free of cost, for the time being.
3. It was decided that all the associations of the federation shall contribute at least Rs.100, 000 in a month's time to meet the ensuing legal expenses. A letter shall be addressed from the President to all the associations.
4. Members from Dhanbad suggested that a dharna should be organized in front of CMPF office, Dhanbad on behalf of the Federation. It was agreed.
5. Issues of CPRMSE and CPRMSNE were discussed and it was suggested that Federation should take up with CIL and its Subsidiaries for hassles-free, cashless treatment to the retired employees and to increase the limit of expenditure.
6. Shri. Dattatreya and Sri.Katiyar will monitor the progress.
7. Meeting ended with vote of thanks to the chair.
